- 1. 7:40pm meeting called to order.
- 2. 2016 HOA dues update
 - Hassan reported that as of last week, annual dues have been received by all homeowners.
- 3. Yard Maintenance
 - Jason Doll reported that the Landscape committee has completed their first walk around of the year.
- 4. Liabilities for Trees in HOA Owned Greenbelt
 - Hassan has reviewed our insurance policies and is questioning whether or not there is coverage available if a tree was to fall and cause damage or injury. Steve will call CAU to review liability coverage for the trees in our greenbelt.
 - Hassan has voiced concern regarding the expense and liability of cutting down hazardous trees in the greenbelt. The group will brainstorm regarding this topic and will reconvene at our next meeting.
- 5. Summer Block Party
 - Targeting August 3rd for our annual neighborhood picnic (2nd choice is August 10th).
 - o We will likely hold the picnic at our neighborhood park again.
 - Mike will reach out to Karen Gordon and Scott Dunphy to see if they would be willing to organize the event.
- 6. Office 360 HOA email
 - Jason to give access to the board this coming week. Hassan will have a separate account as the Treasurer, but all board members will have equal access to information.
- 7. Misc. Landscape Committee requests/notifications.
 - Sandy Vivion and Jan Pickering have been walking the neighborhood and have noted the following:
 - Several topped street trees, but unless trees die there is nothing for us to do. However, Jason will review the landscape standards in our CCRs for details on maintaining.
 - Park sign needs pressure washing, wood benches need to be replaced, and wood chips need to be refilled. Mike to follow up on these items.
 - Entry monument lettering needs to be repaired and center cedar may need to be replaced. Steve will contact sign company for repair of the sign.
 Board members will take a look at the tree and will reconnect at next meeting.
 - Exposed wire box 14828 on the street lamp. Need to contact city to request repair.
 - South end street berm has a small dead tree that needs to be removed.
 Mike will remove.

- Pressure washing under mailboxes needed.
- Retention pond concern that trees around pond may be getting to large and may cause problems.
